## ACADEMY FELLOW AWARD

**Dr. Wesley G. Jennings, *University of Mississippi***

*For distinguished contributions to criminal justice education and scholarship*

Dr. Jennings has amassed over 250 publications and nearly 10,000 citations. His demonstrated excellence in teaching, scholarly productivity, national and international recognition as a scholar, impressive record of service and contributions to ACJS, various awards and recognition, and many years of service as an office holder in the Southern Criminal Justice Association made him an ideal and deserving candidate for the award.



## ACADEMY FOUNDER'S AWARD

**Dr. J. Mitchell Miller, *University of North Florida***

*For outstanding service to ACJS and the profession*

Dr. Miller's contributions over the past 25 years include editor of the *Journal of Crime & Justice*, *Journal of Criminal Justice Education*, and the *American Journal of Criminal Justice*; the 38<sup>th</sup> president of the Southern Criminal Justice Association; ACJS pre-conference professional development workshop presentation; and multiple professional organization and US DOJ committee and project assignments. He previously received the ACJS Fellow and Bruce Smith, Sr. awards that, with the Founder's, puts him in a small group of seven colleagues to receive all three of the Academy's major accolades.



## ACADEMY NEW SCHOLAR AWARD

**Dr. Julie Marie Baldwin, *American University***

*For outstanding scholarly contributions to the study of crime and/or criminal justice by someone who has received their most recent doctoral degree in the past 6 years*

Since graduation (2013), Dr. Baldwin has obtained approximately \$9.5 million in grant funding as PI or Co-PI, as well as produced 18 academic peer-reviewed publications, 1 book chapter, and 23 practitioner reports, resources, or publications. The majority of Dr. Baldwin's work is translational research conducted through research-practitioner partnerships in which she works closely with agencies and programs on evaluation research to produce practical evidence-based recommendations for implementation in the field.

## Spotlight: Comments from Dr. Brandon Applegate



### SCJA 2019 Outstanding Educator Award Recipient

*The 2019 SCJA Awards Luncheon was a great success but ran over time. As such, we're spotlighting the comments that were going to be provided at the luncheon by the SCJA Outstanding Educator Award recipient: Dr. Brandon Applegate, University of South Carolina.*

I am truly honored to receive the Outstanding Educator Award for 2019. The Southern Criminal Justice Association has been my academic home away from home for more than 20 years, so it is a special privilege to be recognized in this way by a group that has been so important to me. I would like to thank the award committee – Wes Jennings, Holly Ventura Miller, and Bruce Arrigo. I hope that their task was not an arduous one, but I am sure it was not easy. Southern has always been blessed with many people who are deeply devoted to higher education in criminal justice. I also want to thank (and possibly embarrass) those who nominated me for this honor – Riane Miller Bolin, Heather Ouellette, and Mateja Vuk.

When Bryan Miller contacted me to let me know I would be receiving this award, it got me thinking, “how did I get here?” To borrow the subtitle from a favorite book of mine, the outset at least was “an unexpected journey.” As an undergraduate student, I found criminal justice to be fascinating. I loved that it drew on the insights of psychology, sociology, political science, and law. The concepts, ideas, and policy implications sparked my imagination, and I was drawn to the human side of our discipline. As I approached the end of my studies, however, I had no idea what I wanted to do. Fortunately, one of my professors invited me to be involved in some research he was conducting and mentioned to me the possibility of graduate study. I found that I had a knack for approaching criminal justice issues from a theoretical and empirical perspective, and going to graduate school meant I could put off deciding what I wanted to do!

This serendipitous start has led to a rewarding career. As academics we get to indulge our intellectual curiosity, but as criminal justices we are also in a unique position to have an impact on the world around us. Borrowing again, this time from the theme of this year's conference, we have the important opportunity for our research and expertise to improve the efficiency and quality of criminal justice. We scrutinize practices, policies, and beliefs by holding them up to logical, systematic, and empirical examination. We support the critical work of professionals by supplying information they can use. We also prepare our students to carry the field and discipline forward. It is through those we teach about the field that we can, perhaps, have the broadest impact on the functioning of the criminal justice system. So, I also want to thank all of you for joining me on this journey because what we do—what *you* do—is important and impactful. Thank you!

# Remembering Dr. Michael J. Leiber

(1956-2020)



Michael J. Leiber's friends and colleagues were sad to announce his untimely passing this year. Mike should be best remembered for his desire to see the world become a better, fairer, and more equitable place. He believed in advancing knowledge to correct the many challenging social ills in society, and this concern for social justice guided his career. Mike grew up in and cherished his home town, Milwaukee. He earned his BA from Marquette University, and then entered the MA program at the University of Wisconsin-Milwaukee. He transferred to The University at Albany, where he earned his MA and Ph.D. He held academic positions at the University of Northern Iowa (1989-2005), Virginia Commonwealth (2005-2010), and the University of South Florida (2010-2020), where he also served as department chair (2011-2019).

His research focused primarily on juvenile justice and disproportionate minority contact with the criminal justice system. He authored over 100 publications, including 76 articles and book chapters, and more than two-dozen government reports, and received more than \$700k in grants and contracts. Mike was the recipient of several scholarly awards of which he was proud, including those from the Division of Minorities and Women (Academy of Criminal Justice Sciences), a lifetime achievement award from the Division on People of Color and Crime (American Society of Criminology), the W. E. B. Du Bois Award from the Western Society of Criminology, and a Distinguished Alumni Award from the University at Albany, among others. He served as editor of the Journal of Crime and Justice, and more recently, Justice Quarterly. He was often an invited speaker at programs and sessions sponsored by the Office of Juvenile Justice & Delinquency Prevention, Washington, D.C..

Many knew Mike in a variety of capacities: distinguished scholar, colleague, mentor, and friend. In his personal life, he was a devoted animal lover to his multiple cats and "fidos." An avid sports fan, he loved his Green Bay Packers, along with the Milwaukee Brewers and Bucks, and the Wisconsin Badgers. He maintained a pristine early 1970s Alfa Romeo Spider. ## Dr. J. Mitchell Miller Named Delaney Presidential Professor



Dr. J. Mitchell Miller, Professor of Criminology and Criminal Justice at the University of North Florida (UNF), has been named the next Delaney Presidential Professor at UNF. This award is based upon Dr. Miller's sustained record of outstanding scholarship, grant funding, and the research projects he has delineated for the years ahead. This Professorship was established through the generosity and support of the Newton and Stein families. Dr. Miller joins Drs. David Courtwright, Gary Smart, Andy Buchwalter, Tom Pekarek, Lev Gasparov, Dominik Guess, John Hatle, and Cliff Ross as a Presidential professor. The Delaney Professor is awarded for up to 3 years and carries with it a stipend and a course release each academic year. The course release is granted in perpetuity contingent upon the awardees' ongoing scholarly productivity.
