Anti-Harassment and Misconduct Reporting for SCJA

FAQs

What is considered harassment or misconduct by SCJA?

Behaviors considered harassment or misconduct include, but are not limited to, the following: financial impropriety of SCJA funds, threats or actions to cause personal or professional harm, unwelcome verbal or physical approach, prejudicial or discriminatory behavior, or continued disruptive behavior at SCJA events.

Who can report harassment or misconduct?

Any participant at a SCJA function can report harassment or misconduct. Participant in this policy refers to anyone present at SCJA meetings or other sponsored events, including staff, contractors, vendors, exhibitors, venue staff, SCJA members and all other participants.

What happens when I make a complaint?

Legal counsel shall communicate to the complainant that the complaint has been received as soon as possible and no later than within 3 business days. The complaint (without identifiers) will then be considered by the Chair and SCJA President and passed to the Misconduct Reporting Committee (MRC) for full investigation if deemed a viable claim.

What correctional measures can be taken by the MRC should the complaint have merit?

The MRC has the right to implement one or more measures for the behavior, ranging from a written warning to revocation of SCJA membership. Correctional measures will only involve participation in SCJA.

Where can I report a complaint?

Complaints can be filed directly on the SCJA website.

Get To Know: Jacob Crawford

Jacob Crawford is a recent graduate from the Master of Arts in Social Science program at Georgia Southern University. His thesis research focused on the roles and responsibilities of riverkeepers in Georgia and the role they play in promoting environmental justice.

Riverkeepers and environmental groups currently face the complex task of defending watersheds. In Georgia, these efforts are complicated by the vast geographical and racial diversity within the state. This study examined the riverkeepers and environmental groups need to improve advocacy abilities to defend communities they serve from poor water quality, what communities in Georgia are being impacted by poor water quality, what disconnects exist between riverkeepers, environmental groups, and governmental agencies, and how COVID-19 has challenged the riverkeepers and environmental groups. Using qualitative interviews with eleven riverkeepers and environmentalists, the findings suggest that collaboration with riverkeepers, enforcement of current policy, defending communities of color, and educating the public on water quality are all critical to maintaining watersheds in Georgia. Minoritized groups, instances of environmental racism, and other challenges presented barriers to water conservation. The riverkeepers and environmental groups provided strategies to address these barriers and improve water quality.

The success of both riverkeepers and environmental groups depend on overcoming these barriers. Even through the COVID-19 pandemic, there has been notable success due to the outdoor nature of their work, niched training, engaging with other groups and the public through virtual means, and creating coalitions across the state of Georgia. Those involved with river projects and enjoying the outdoor environment were able to social distance effectively. One of the most significant findings of this project was enforcement of policy. All of the interviews mentioned the lack of enforcement of water related policy by state level organizations such as EPA, EPD, and DNR. These detrimental impacts increased exponentially in rural areas and impoverished communities. Environmental racism exists in Georgia and based on stories described in this thesis, Georgia's riverkeepers and environmental groups have had to step in to complete the job. Their work in protecting land and waterways is critical and could be driven further by officials in all levels of government.


FORMER SCJA PRESIDENT RECEIVES TRUEBLUE CITATION OF DISTINCTION AT MTSU HOMECOMING

At Middle Tennessee State University's Fall 2021 homecoming ceremonies, Dr. J. Mitchell Miller was awarded the Outstanding Alumni Association's *TrueBlue Citation of Distinction for excellence in Education*. Miller (B.S., 1990; M.C.J. 1991, *MTSU*; Ph.D., 1996, *Univ of Tennessee*) is currently the John A. Delaney Presidential Professor and the Editor of the *American Journal of Criminal Justice* at the University of North Florida following faculty and administrative appointments at the University of South Carolina and the University of Texas San Antonio. Having completed doctoral work at the University of Tennessee in 1996, his applied research agenda has been helpful to the southern region and beyond but especially so regarding his home state through numerous initiatives over the years with criminal justice agencies across Tennessee including several active federally sponsored programs with MTSU criminal justice faculty.

In presenting the accolade, MTSU President Dr. Sydney McPhee noted that Miller is the author of over 200 scientific works, an internationally scholar, and a Fellow of the Academy of Criminal Justice Sciences as well as his diplomatic service to the US State Department and consultation with the US Attorney General's Office. President McPhee praised the social betterment derived from Miller's research based in research-practitioner partnerships with sheriffs, police chiefs, and correctional officials to bring mental health and substance abuse treatment, often into underserved settings such as Franklin, Madison, and Sumter Counties in the Volunteer state.

In an acceptance speech, the native Tennessean noted the sacrifice of his late parents (Jim and Carme Miller of Brentwood, TN) – particularly for enabling preparatory schooling at the Lipscomb Academy in Nashville for himself and younger brother. He credited Lipscomb for the brothers' competitive head start, Christian outlook, and principled fortitude for success, thanked MTSU criminal justice faculty for decades of fellowship, especially recently retired Department Chair Lance Selva and MTSU criminal justice alumni. Miller concluded his statewide broadcast soliloquy with a moving tribute to his wife and former SCJA President Dr. Holly Ventura Miller, noting her unswerving loyalty, professional contributions and constant assistance, and longsuffering with his absence and domestic neglect from excessive work. Joining Mitch and Holly for the two-day event were younger brother J. Matthew Miller, a prominent Clarksville TN attorney and former recipient of the SCJA Outstanding Graduate Student Award, close colleague and new SCJA Board Member Dr. Ben Stickle, and longtime friends and MTSU alumni and Columbia, TN attorney Brian Hay and Nicki Hay. After the Friday night award ceremony, the Millers rode in the MTSU Homecoming parade and was recognized on the field during the game with Southern Mississippi.
