

Sponsored by the Southern Criminal Justice Association since 1975, the American Journal of Criminal Justice disseminates empirical research and academic commentary on a wide array of criminal justice topics and issues. Published by Springer, AJCJ features original and applied research articles that employ a broad range of methodologies and theoretical perspectives. The journal has been on a multi-year ascension in publication rankings, having reached #3 in Criminology and Penology in 2022 with an impact factor over 6.0.



The official start date is January 1, 2024, with orientation and training to begin this fall. Solo editor and co-editor applications are welcome. Finalists will be invited to an online interview with the search committee during summer or early fall 2023.

**Application Requirements:** 

- 1. Applicants must be members of SCJA at time of submission.
- 2. Current CV of the editor or co-editors.
- 3. Cover letter to include:
  - o Editorial experience.
  - o Vision for AJCJ.
  - o Plans for editorial board.
  - o Disclosure of any current or pending retractions or cases with COPE.
  - o Statement of how diversity, equity, and inclusion will be central to the journal's mission.
  - o Resources needed from the publisher and SCJA.
  - o Statement of university support (e.g., faculty release time, travel funds, summer salary, office space, utilities, the use of computers and other office equipment, support for a managing editor, student workers, and/or other basic expenses).

Billy Vahldiek Captain

Bill (Billy) Vahldiek has become a regular face at SCJA conferences as one of the association's foremost practitioner members. After working through the ranks in law enforcement since 1993 and with the Gallatin (TN) Police Department since 1998, Billy was recently promoted to the rank of Captain in 2022. He previously held positions of Patrol Officer, Field Training Officer, Corporal, Sergeant and Lieutenant. Captain Vahldiek currently oversees the department's support and training divisions while assisting with dispatch, criminal investigations, patrol and crime prevention.

Billy studied at Sam Houston State University, has a B.S. Degree in Criminal Justice from Bethel University, and is a graduate of the 332th class of the School of Police Staff and Command of Northwestern University. He is an active member of the Tennessee Law Enforcement Training Officers Association, Tennessee Association of Chiefs of Police, Fraternal Order of Police Lodge 65, FBI NA, and Bethpage Masonic Lodge #521. A strong advocate of researchpractitioner partnerships, Billy has successfully partnered with criminal justice scientists and criminologists to secure millions of dollars in resources for justice mental health, substance abuse intervention, officer well-being, and law enforcement staffing analysis. The SCJA recognized his contributions to criminal justice and support of academe with the Outstanding Practitioner Award at the Daytona Beach conference in 2021. ## UPCOMING 2023 ELECTION EXECUTIVE BOARD

The SCJA 2023 election is fast approaching and will be held for the positions of: Second Vice-President, Treasurer, and two Directors-at-Large.

#### **Descriptions and Responsibilities**

The **Second Vice-President** shall preside at Annual or Special Meetings of the Association in the absence, disability, or removal of the President and First Vice-President. The Second Vice-President shall automatically succeed to the office of President should the President and First Vice-President be unable to complete the elected terms of office. In addition, the Second Vice-President shall serve as First Vice-President for the year following the election to Second Vice-President. The duties of the Second Vice-President (First Vice-President) shall be:

- To assist the President and First Vice-President as requested;
- •To assume responsibility for Association awards;
- •To assume responsibility for selecting the sites of future Annual Meetings;
- •To perform such other duties as directed by the President or the Board of Directors.

The **Treasurer** shall serve a term of three years or until their successors have been duly elected and qualified. Duties of the Treasurer include:

•To keep an accurate record of all monies received, deposited and disbursed in the name of the Association;

•To sign or designate and oversee the signing of all orders drawn on the funds of the Association as authorized;

•To provide a treasurer's report at board and business meetings.

•To perform such other duties as directed by the President or the Board of Directors.

The Board of Directors shall consist of the immediate past President, the elected Officers, and five (5) **Directors-at-Large**. The Board of Directors shall provide general policy direction for the Association and perform ad hoc tasks at the discretion of the President, and are expected to attend all meetings of the Association. Directors-at-Large shall serve a term of three years or until their successors have been duly elected and qualified.
